("Gestmin") hereby informs and discloses the acquisition, on 26 August 2016, of 353,662 ordinary shares of CTT at an average price of €6.60/share.

Hence, following this transaction, the Member of the Board of Directors Manuel Carlos de Mello Champalimaud currently holds, directly and indirectly, 13,073,391 (thirteen million seventy-three thousand three hundred and ninety-one) shares representing 8.72% of the share capital and voting rights of CTT.
